- Medical, counseling, or psychological facts or evaluations concerning an individual if the individual's identity would be revealed by a disclosure of those facts or evaluation, including protected health information, as defined in 45 CFR 160.103.

In the event you are not satisfied with this response, I want to advise you of your rights. You have the right to submit a written appeal to the head of the Mason County Sheriff's Office who is Sheriff Cole, specifically stating the word "appeal" and identifying the reason or reasons for reversal of this denial.

In addition, you may also seek judicial review of this denial pursuant to MCL 15.240. If you seek judicial review and the court determines the public records are not exempt from disclosure, you have the right to receive attorney fees and damages in an amount not to exceed \$1,000.000.
